You are about to join a Vessel for Delta Marine Crewing.

Before you leave we would like to receive a colour scan of the following valid certificates, if you haven't done so yet;

- A valid passport / ID
- US visa (when needed)
- COC
- Seamansbook front page and sailing time
- Medical certificate, both pages
- Basic safety
- Advanced Fire Fighting
- Proficiency survival crafts
- High Voltage
- DSD and/or SSO
- ECDIS
- Shipsmanagement
- Vaccinations (stamped and signed pages yellow booklet)
- Any other relevant certificates for the project or Vessel type

At all times you will be held responsible for the validity of the above certificates during your contract, please check them before departure. Always bring your **Original** documents on board.

Vaccinations:

- Yellow Fever
- Cholera (after date of issue valid for 6 months)
- Typhoid
- DTP
- Hepatitis A en B (not mandatory)
- Covid-19

Do you have all vaccinations before your travel?

Are you in the possession of all **Visa's** that are mandatory for the countries you will travel to?

Have you informed us of your **NOK** (Next of Kin) details?

Before departure you need to be informed of the **contact** details of the local agent, Ship and Shipping company.

When you are travelling by **plane** please follow our instructions and make sure that you will check in at least two hours ahead of time.

Before traveling please check the **itinerary** of your own government.

For a correct and prompt payroll administration we would like to receive your **Timesheet/Monthly report**, signed by the captain inclusive of declarations and a copy of all receipts, at the latest the 3rd workday of each month or 3 days after the end of your contract.

Maximum declaration for food is € 25,- per travelday. Alcoholic drinks will not be reimbursed. Taxicosts will only be refunded after approval. Please send this all-in a pdf file to info@deltamarinecrewing.nl.

Complaints could be submitted directly to the shipping company or at all times at Delta Marine Crewing per e-mail, by phone or per letter. Always mention as subject "**Official Complaint"**. You will always receive a confirmation. Complaints will be dealt with within 20 days, when this cannot be achieved you will receive a notice on when a solution can be expected. Once solved you will receive a confirmation in writing of the procedure followed.

The **Alcohol and Drug policy** adhered to will be conform the shipping companies policies. Ask for the policies upon arrival. Excessive use of alcohol or use of during duties is at all times prohibited.

Check all your safety equipment before you leave and at all times bring **safety shoes** and a **coverall** to the Vessel.

Upon arrival to the Vessel please check and adhere to the safety policies.

Insurance for **repatriation** and **medical cost** other than homeland are always covered by Delta Marine Crewing as long as you are working or traveling for us. Always **inform** our office **before** you visit a doctor or seek any medical help.
